I further understand that this agreement is **non-cancelable**, and that my failure to take all lessons contracted for, shall not relieve me of my obligation to pay the total tuition herein agreed upon. I further understand that I will not be entitled to a refund of any tuition heretofore paid, caused by my absence or withdrawal from the lessons herein specified. I further understand that, should I fail to pay any installment when due, the unpaid balance of this contract, at *kSp*'s option, shall become immediately due and payable, together with all costs and expenses of collection, including reasonable attorney's fees.

Studentship is subject to approval by KidScape Productions, and shall be effective only when this agreement is approved by *kSp*. THE UNDERSIGNED ACKNOWLEDGES THAT HE/SHE HAS READ AND UNDERSTANDS THE GENERAL TERMS AND CONDITIONS OF THIS AGREEMENT AND AGREES TO BE BOUND BY SUCH TERMS AND CONDITIONS AND ACKNOWLEDGES THAT HE/SHE HAS RECEIVED A COPY OF THE AGREEMENT.

GENERAL TERMS AND CONDITIONS

It is expressly agreed that Students assume all risks related to his/her participation in the lessons provided by *kSp*.
